

WTTA RULE SUMMARY: REFER TO FULL RULES FOR DETAILS AND ADDITIONAL INFORMATION

MATCH PLAY:

MATCH TIMES ARE 9:30 OR 11:30

LINEUPS SHOULD BE EXCHANGED AT 9:15 OR 11:15, IF ALL PLAYERS ARE PRESENT

TEAMS USING ANY "ILLEGAL PLAYER" WILL FACE A PENALTY

SUBS MAY SUB AT THE FLIGHT LISTED OR ANY HIGHER FLIGHT, ROSTER PLAYERS MAY SUB IN HIGHER FLIGHTS THEN THEIR OWN.

ALL RESULTS MUST BE INPUT INTO WEBSITE BY MIDNIGHT THE DAY FOLLOWING THE MATCH. THIS INCLUDES EACH RAIN MAKEUP LINE AS WELL. RESULTS NOT INPUT WILL BE VOID

DEFAULTS:

PLAYERS NOT PRESENT AND READY TO PLAY AT MATCH START TIME (9:30 OR 11:30) WILL BE DEFAULTED

DEFAULTS SHOULD GO FIRST TO LINE 4, THEN LINE 3, ETC.

IF A DEFAULT OCCURS, BOTH TEAMS CAN REVISE THEIR LINEUPS ACCORDINGLY

ANY TEAM THAT DEFAULTS 2 OR MORE LINES IN A SINGLE MATCH WILL FACE A PENALTY

IF THERE IS A CATASTROPHIC EVENT (AS DETERMINED BY WTTA) THEN DEFAULTS WILL NOT BE GIVEN AND TEAMS WILL EITHER ALLOW LATE ARRIVING PLAYERS TO PLAY AT THAT TIME OR LINES AFFECTED WILL BE RESCHEDULEED

WEATHER:

TEAMS MAY CANCEL MATCHES IN THE EVENT OF RAIN OR WET COURTS

TEAMS MAY ALSO CANCEL FOR THE FOLLOWING WEATHER CONDITIONS:

ACTUAL TEMPERATURE OF 40 AND BELOW, OR 100 AND ABOVE

WIND CHILL OF 32 AND BELOW

RESCHEDULES:

TEAMS MAY RESCHEDULE LINES AFFECTED BY SCHOOL OR RELIGIOUS HOLIDAYS, OR USTA SECTIONAL OR NATIONAL TOURNAMENTS, WITH APPROPRIATE NOTIFICATION BOTH BEFORE THE SEASON AND AT LEAST TWO WEEKS PRIOR TO THE MATCH

ALL RESCHEDULES MUST HAVE NEW DATES DECIDED AND INPUT WITHIN 72 HOURS.

ALL MATCH RESCHEDULES MUST BE COMPLETED BY 21 DAYS FROM THE ORIGINAL MATCH DATE OR 14 DAYS FROM ANY RESCHEDULED DATE, WHICHEVER IS LATER

ALL MATCHES MUST BE COMPLETED BY 14 DAYS AFTER THE LAST SCHEDULED MATCH FOR EACH FLIGHT

THANKSGIVING WEEK AND SPRING BREAK WEEK WILL NOT COUNT IN CALCULATING ANY DEADLINES

LINES THAT HAVE NOT AGREED ON A NEW DATE WITHIN 48 HOURS MUST CONTACT THE FLIGHT COORDINATOR FOR ASSISTANCE AND HAVE A DATE CHOSEN

IF COURTS ARE NOT AVAILABLE AT THE ORIGINAL HOME TEAM LOCATION THEN THE VISITING TEAM MAY PROVIDE COURTS INSTEAD. IF NEITHER HAS COURTS, A NEW DATE WILL BE CHOSEN
